PURSUANT TO DEPARTMENT OF COMMERCE MOBILE HOME COMISSION GENERAL RULES:

R125.1602. INSTALLATION, RULE 602. (1) FOR ALL NEW MOBILE HOMES SOLD IN MICHIGAN, THE MANUFACTURE SHALL PROVIDE EXPRESS WRITTEN INSTRUCTIONS FOR THE INSTALLATION SPECIFYING THE LOCATION AND REQUIRED MINIMUM IMPOSED LOAD CAPACITY OF PILLARS AND THE LOCATION AND THE REQUIRED MINIMUM IMPOSED LOAD CAPACITY OF ANY OTHER RECOMMENDED DEVICES.

RULE 602 (2) IN THE ABSENCE OF THE MANUFACTURES INSTALLATION INSTRUCTIONS, THE INSTALLATION OF MOBILE HOMES SHALL, AT A MINIMUM, COMPLY WITH: RULE 602 (2a) (2b) (2c) (2d) (2e) (2f) (2g) (3) (4) (5) (6) (7) (8).

***NOTE: IT SHALL BE UNLAWFUL TO OCCUPY A MOBILE HOME PRIOR TO FINAL INSPECTION APPROVALS AND A CERTIFICATE OF OCCUPANCY BEING ISSUED.**
